(AMENDMENT) ORDER, 1958.

The Government, in exercise of the powers conferred on them by section 1 of the Red Cross Act, 1938 (No. 32 of 1938), hereby order as follows:

- 1. This Order may be cited as the Irish Red Cross Society Order, 1939 (Amendment) Order, 1958.
- 2. Article 8 of the Irish Red Cross Society Order, 1939 (S.R.& O., No. 206 of 1939), is hereby amended as follows:
 - (I) in subparagraph (i) of paragraph (a) of sub-article (4) "(being a year not later than the year 1960) and before the 1st day of May in each nomination year (being a year after the year 1960)" shall be inserted after "year",
 - (II) in subparagraph (ii) of paragraph (a) of sub-article (4) "(being a year before the year 1960), and before the 1st day of May, in the year 1960 and each subsequent year," shall be inserted after "subsequent year",
 - (III) in subparagraph (i) of paragraph (b) of sub-article (4) "(the nomination year being before the year 1958), for the period from the 1st day of July, 1958, to the 30th day of April, 1961 (the nomination year being the year 1958) and for a period of three years from the 1st day of May next following his nomination (the nomination year being after the year 1958)" shall be inserted after "nomination",

- (IV) in subparagraph (ii) of paragraph (b) of sub-article (4) "(the year of election being before the year 1959), for the period from the 1st day of July, 1959, to the 30th day of April, 1960 (the year of election being the year 1959) and for the period of one year from the 1st day of May next following the date of his election (the year of election being after the year 1959)" shall be inserted after "election",
- (V) the last four sub-articles shall be renumbered "(5)", "(6)", "(7)" and "(8)" being substituted for "(3)", "(4)", "(5)" and "(6)" respectively.
