OFFENCES AGAINST THE STATE (AMENDMENT) ACT, 1940

SECTION 9

Return from 1st March, 1961 to 31st July, 1961, inclusive, to be  
laid before each House of the Oireachtas.



- (a) Particulars of persons detained under Part II of the Act Nil
- (b) Particulars of persons in respect of whom the Commission has made a report to the Government Nil
- (c) Particulars of persons in respect of whom the Commission has reported that no reasonable grounds exist for their continued detention Nil
- (d) Particulars of persons who had been detained under Part II of Act but who had been released on the report of the Commission Nil
- (e) Particulars of persons who had been detained under Part II of Act but who had been released without a report of the Commission Nil

Note: A return for the period ending on 28th May, 1959, was presented to both Houses on 5th June, 1959, and gave particulars of all persons detained from 8th July, 1957, to 11th March, 1959, since when no person has been detained under Part II of the Act.
