WHEREAS it is enacted by section 38(1) of the Offences against the State Act, 1939 (No. 13 of 1939), that, as soon as may be after the coming into force of Part V of that Act, there shall be established, for the purposes of that Part, a court which shall be styled and known and is in that Act referred to, as a Special Criminal Court;

AND WHEREAS it is enacted by section 39(1) of the Offences against the State Act, 1939, that every Special Criminal Court established under Part V of that Act shall consist of such uneven number (not being less than three) of members as the Government shall from time to time determine;

AND WHEREAS Part V of the Offences against the state Act, 1939, is in force :

NOW, the Government, in pursuance of section 38(1) and section 39(1) of the Offences against the State Act, 1939, hereby establish a court for the purposes of Part V of that Act and determine that that court shall consist of three members,
