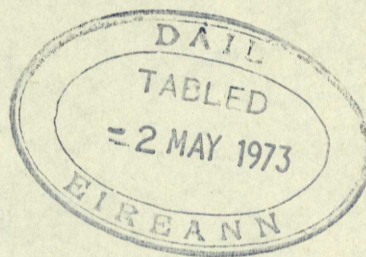

IRISH RED CROSS SOCIETY (AMENDMENT)

ORDER, 1973

---

The Government, in exercise of the powers conferred on them by section 1(3) of the Red Cross Act, 1938 (No. 32 of 1938), hereby order as follows:

1. This Order may be cited as the Irish Red Cross Society (Amendment) Order, 1973.
2. Notwithstanding anything contained in the Irish Red Cross Society Order, 1939 (S.R. & O., No. 206 of 1939), as amended by the Irish Red Cross Society Order, 1939 (Amendment) Order, 1958 -
  - (a) each member of the Central Council of the Irish Red Cross Society nominated to office by the Government and holding office on the 30th day of April, 1973, shall continue to hold office as such member until the 31st day of July, 1973, and
  - (b) the Government may, at any time before the 1st day of August, 1973, nominate, pursuant to Article 8 (4) (a) of the said Irish Red Cross Society Order, 1939, persons to be members of the said Central Council and a member nominated pursuant to this paragraph shall, unless he sooner dies or resigns, hold

office from the 1st day of August, 1973,  
until the 30th day of April, 1976.


