I,	, Minister for Health, in exercise of the powers conferred on me by
sectio	n 45(3) of the Health Act 1970 (No. 1 of 1970), with the consent of the Minister for
Public	Expenditure, National Development Plan Delivery and Reform, hereby make the
follov	ving Regulations:
1.	These Regulations may be cited as the Health Act 1970 (Section 45(3)) (Classes of
Perso	ns) Regulations 2024.

2.	In these Regulations –

3.	The following classes of persons are specified for the purposes of section 45(3) of the
Health	Act 1970 (No. 1 of 1970), namely:

- (a) a relevant person
  - (i) in respect of whom a general payment or both a general payment and a work related payment has been made to him or her under section 32(1)(a) of the Act of 2023,
  - (ii) who, immediately prior to such payment or payments, as the case may be, being made to him or her, had full eligibility under section 45(1) of the Act of 1970, and
  - (iii) who, but for that payment or payments, as the case may be,would continue to have such full eligibility;
- (b) a relevant person
  - (i) in respect of whom a general payment or, both a general payment and a work related payment has been made to him or her under section 32(1)(a) of the Act of 2023,

- (ii) who immediately prior to such payment or payments, as the case may be, being made to him or her, did not have full eligibility under section 45(1) of the Act of 1970, and
- (iii) who, notwithstanding (ii), would, if he or she were to be assessed for the purposes of section 45(1) of the Act of 1970, be deemed, but for such payment or payments, as the case may be, to have full eligibility under that section.
