PHOENIX PARK ACT, 1925.

LICENCE FOR THE EXCLUSIVE USE OF A PORTION OF THE PHOENIX PARK

From

11p.m. on Wednesday, 29 May 2024 until 11p.m. on Monday, 3 June 2024 inclusive

The Commissioners of Public Works in Ireland, in exercise of the powers conferred on them by Section 4 of the Phoenix Park Act, 1925, hereby grant a Licence to

Bord Bia, 140 Pembroke Rd, Ballsbridge, Dublin 4

for exclusive use of that portion of the Phoenix Park (surrounding the Ashtown Visitor Centre) on the occasion of Bord Bia staging “Bord Bia Bloom”.

This Licence is granted subject to compliance in full with the provisions of the Phoenix Park Act, 1925, the Phoenix Park Bye Laws, 1926, the Terms and Conditions set down by the Commissioners of Public Works and all other statutory requirements.
