

## FOREWORD



Dear Minister,

I am pleased to present the Annual Report of the Official Censor of Films for 2004 as prescribed by Section 29 of the Video Recordings Act, 1989.

The following were among the principal developments in what was a busy year for IFCO:

- There was a significant increase in the total number of cinema films and video/DVDs certified.
- Since its official launch by you on 3rd September, the IFCO website has been providing the public with general information about what we do as well as giving consumer advice to parents on films and videos/DVDs.
- We published the findings of a major national survey of parents carried out for IFCO by Lansdowne Market Research.
- A new '16' cinema certificate and the re-designation of two existing certificates was announced, to come into effect from January 2005.
- The appointment of five additional part-time Assistant Censors was announced, a welcome development in the light of the increasing numbers of cinema films and video/DVDs being certified.
- The recruitment of an Inspector, with responsibility for monitoring compliance with the provisions of the 1989 Video Recordings Act, has been welcomed by the legitimate industry.
- The IT Division of the Department of Justice, Equality and Law Reform completed the first stage of a major integrated IT system for IFCO.
- At the launch of our website in September, you indicated that you would be considering a general review of censorship legislation.

I would welcome any such review, not least because in today's world of multiple media access and internet download, the statutory remit of the Film Censor, as I pointed out in my 2003 Annual Report, remains essentially the same as when it was first established during the silent screen era by the Censorship of Films Act, 1923.

My colleagues and I at IFCO would welcome the opportunity to make a constructive contribution to whatever process you may decide to initiate.

Finally, I would like to express my appreciation of the contribution made during 2004 by my colleagues at IFCO, the Deputy Censor, Ger Connolly, together with his team of Assistant Censors, and our Office Manager, Eileen Fitzgerald, and her civil service colleagues. I would also like to acknowledge the valuable contribution of Violet Ennis, an Assistant Censor at IFCO since 1993, who retired during 2004.

### ■ Increased Activity

In comparison with 2003, the number of cinema feature films certified increased by 17% and the number of video/DVDs certified increased by 16%. In the case of cinema films, the increase in the number certified can be largely attributed to the welcome introduction in April of a reduced fees charge for limited release films (low budget, foreign language, arthouse, etc.). In the case of video/DVD, the increase can be attributed to further major growth in the DVD market, even though that market is seriously affected by piracy and illegal imports.

### ■ IT and Technology Solutions

In late 2003, the IT Division of the Department of Justice, Equality and Law Reform undertook a review of IFCO's IT resources. This indicated that the Progress and DataEase based accounting systems used by IFCO to manage transactions with film and video distributors, which were over ten years old, provided insufficient functionality to support an expanding business requirement.

In addition, it was agreed that an upgraded network infrastructure would be required to support the continued operation of current and future business applications.

During 2004, the IT Division of the Department of Justice, Equality and Law Reform successfully implemented and tested the first phase of a major modernisation of IFCO's infrastructure, systems and applications.

Phase 2, which will be completed during 2005, will build on the interim steps achieved in Phase 1 and will result in a fuller delivery of technology solutions involving infrastructure, applications and dynamic web services.

### ■ Website

Following a test period, which included consultations with parents, the public and the industry, the IFCO website was launched on 3rd September, 2004.

The aim was to create a dynamic, user friendly and visually stimulating environment, within which IFCO could fulfil its statutory remit. At the same time, the intention was to send out a clear message that the Film Censor's Office had been significantly modernised.

*The main goals for the site were:*

- To inform the public in a clear and concise manner about what we do at IFCO.
- To publish general guidelines explaining our approach to classifying films and video/DVDs.

- To provide parents with consumer information about specific films so they can monitor and approve their children's viewing.
- To marry the day-to-day requirements of IFCO's public service remit with the entertainment appeal of the film industry.

As can be seen, the site's content is geared strongly towards movie release dates. It is updated daily and the new cinema releases are published each Friday. It contains a searchable index of all movies that are on release in Ireland as well as those that have been classified since the site's launch. It is planned to extend this database to include films classified in earlier years, as well as video/DVD releases, in due course.

In terms of the site structure and navigations, the aim was to be consistent, intuitive and transparent, offering easy access to the breadth and depth of the site's content.

In terms of visual design, the aim was to be striking, stimulating and stylish, with a relevance for the audience and message the site supports – i.e. it should be graphically appealing and incorporate movie images as well as links to reviews and movie websites.

The site has been welcomed by the public, by parents and by the entertainment industry. Feedback from several of our international counterparts, e.g. UK, Australia, France, has been positive.

### ■ Revised Cinema Fees

A revised scale of fees for certifying cinema films was implemented by Ministerial Order (Statutory Instrument No. 114 of 2004), which came into effect from 1st April 2004.

As stated in IFCO's 2003 Annual Report, there had been no increase in the scale of fees charged for certifying cinema films since 1987.

While the fees charged for certifying mainstream cinema films were increased, the fees charged for certifying 'art house' or limited release films – e.g. sub-titled, low budget, indigenous films, minority interest, etc. - were significantly reduced.

In the past, it cost as much to certify an art-house film as a mainstream one. Now, as a result of the new scale, the cost of an art-house film is one quarter of the cost of a mainstream one, and it is therefore financially feasible for distributors to release such films now.

As I had called for this initiative to be introduced in my Annual Report for 2003, I am particularly pleased to welcome it now. It has also been warmly welcomed by the the film going public and the Irish film industry.

Between 1st April and 31st December 2004 seventy three limited release films were certified, including *The Cooler*, *Imagining Argentina*, *Omagh*, *Ae Fond Kiss*, *The Edukators*, *The Return*, *9 Songs*, *My Summer of Love*, *The Best of Youth*, *Before Sunset*, *Freeze Frame* and *Japanese Story*.

## ■ Revised Video Fees

A revised scale of fees for certifying video works and issuing licences was implemented by Ministerial Order (Statutory Instrument No. 113 of 2004), which came into effect from 1st June 2004.

As stated in IFCO's 2003 Annual Report, there had been no increase in the scale of fees charged in this regard since they were first introduced in 1994.

A two tier fee scale for certifying video works, similar in concept to that outlined above for certifying cinema films, would be a further positive development. Representations were made to IFCO during 2004 in this regard by both Irish and foreign video distributors, requesting that a lower fee be charged for certifying non-mainstream video titles that might otherwise prove uneconomic to release.

I believe this to be a reasonable request and, following further discussions with industry representatives, a proposal has been sent to the Department of Justice, Equality and Law Reform for the Minister's consideration.

## ■ Changes to Cinema Film Certificates

Two changes to the existing film certificate categories were announced on 9th December, to take effect from 1st January 2005.

1. The existing '12PG' and '15PG' certificates were re-designated '12A' and '15A', with the 'A' denoting adult.
2. A new '16' certificate was introduced, restricting cinema admission to persons aged sixteen and over.

Among the first films to be certified as '16' were 'Kinsey', 'Team America: World Police' and 'Million Dollar Baby'.

These changes were made following consultations with parents, educators, the public, film distributors and cinema managers. They also took into account the findings of the nationwide survey of parents that Lansdowne Market Research had carried out for IFCO earlier in the year.

## ■ Parents Survey

The results of the first ever national survey of parents on issues relating to their children's viewing of film and video/DVDs was published by IFCO on 3rd September.

The primary aim of the survey, which was carried out for IFCO by Lansdowne Market Research, was to identify the main issues of interest to parents in relation to film and video content and classification.

Lansdowne surveyed over 250 parents of children attending 12 post-primary schools, which were randomly selected to provide a representative sample in terms of area, socio-economic, gender and religious composition.

Among the main findings of the Lansdowne survey were:



- 86% of parents believe they should have the final say on what their children can and cannot watch.
- The majority of parents are aware of IFCO and of what it does.
- 93% of all parents say they regularly check the classification rating.
- On the whole, parents are happy with the current classifications (G, PG, 12PG, 15PG and 18). They see them as one of the main sources of useful information about film content and as an important reference when they are deciding what their children should or should not watch.
- However, there is confusion because, by itself, PG denotes 'parental guidance', but when it's 12PG or 15PG it means 'parent or guardian accompanied'.
- Two out of three parents say they regularly agree with IFCO's classification decisions.
- One in three say that they sometimes disagree – and the majority of those say IFCO is too strict.
- Just over 40% of parents believe that some 12PG rated films have been 'too strictly' classified, whereas 25% feel some were 'not strictly enough' rated.
- 45% of parents feel 15PG films are often or sometimes too strictly rated, while 38% feel that, on occasions, IFCO is too lenient.
- The primary content concern of most parents is drugs/drug taking and violence, followed by racial references and underage drinking of alcohol. Sexual activity/dialogue is a cause of less concern today, and most parents comfortably distinguish between sexual content and nudity. Swearing and strong language is very low down on concern priorities.
- Interestingly, a majority of parents believe that it is 'the overall context and underlying messages of a film that should be the basis for classification - not individual scenes'
- Where older adolescents are concerned, parents see the internet and television as potentially more harmful influences than films and video/DVDs.
- Parents would welcome more information about the content of films. Almost half said that they would visit the IFCO website.

## ■ Adolescents Survey

The second phase of the research project, undertaken jointly by Dublin City University and the IADT, Dun Laoghaire, under the supervision of Dr Carol MacKeogh, will report on adolescent perspectives on film classification in early 2005.

## ■ Assistant Censors

Five new part-time Assistant Censors were appointed in November: Mark Brennan, Alison Foley, Dani McCafferty, Patricia Murphy and P.J. Sheridan.

These appointments, which include expertise/experience in print and television journalism, legal studies and film distribution, were particularly welcome as work volumes have increased significantly in recent years at IFCO.

## ■ Inspector Post

A recruitment process was initiated in November to fill the post of Inspector which had remained vacant for some years. The new Inspector will take up the post in January 2005.

As an agency within the Department of Justice, Equality and Law Reform, IFCO has been able to establish an effective liaison with the Gardai, and it is envisaged that the Inspector appointment will encourage greater compliance and lead to more prosecutions for breaches of the Act.

The Piracy Steering Group of the Irish video/DVD industry has informed IFCO that 64% of the legitimate video/DVD business in Ireland is lost to piracy each year, equivalent to approximately €115 million.

## ■ Focus Groups

Several focus group screenings were held during the year as a means of engaging with, and exploring the opinions of, parents, young persons, second and third level students, educators, psychologists, etc.

An initiative has been established with the IFI (Irish Film Institute) to provide a platform for second level students to engage with IFCO in discussing classification and censorship issues following screenings. This will be further developed in 2005 as a regular and nationwide initiative.

Among films screened at focus groups in 2004 were:

*A Very Long Engagement, Shattered Glass, The Best of Youth, The Barbarian Invasions, The Ketchup Effect, Open Water, Shrek 2, The Isle, Zatoichi, Harry Potter and the Prisoner of Azkaban and Sideways*

## ■ Proposed Legislative Reform

As stated earlier, my colleagues and I at IFCO look forward to contributing towards the proposed review of censorship legislation.

The role of the Film Censor, as set out in the 1923 Censorship of Films Act, was defined for times that could scarcely be more different to the social, cultural and media environment that obtains in Ireland today. Indeed the term 'Censor' itself has long since been discarded as a title by most other countries.

In my view, despite its critics, the main reason that the 1923 Act has broadly stood the test of changing times is because those who drafted it defined the determining factor in certifying (or censoring) a film to be the opinion of the Film Censor. The phrase 'in the opinion of the Film Censor' enabled the Film Censor of the day to exercise discretion in deciding what might or might not be, for example, 'obscene' or 'contrary to public morality'.

Although introduced more recently, the Video Recordings Act, 1989, has also been somewhat overtaken by events, not least the advance of technology and a rapidly changing media marketplace.

## ■ Video Games

Video games are exempt from classification under the Video Recordings Act 1989.



However, Ireland is a member of PEGI, the Pan European Games Information system. The Deputy Censor, Ger Connolly, is a member of the PEGI Advisory Board.

The other members of PEGI are Austria, Belgium, Denmark, Finland, France, Greece, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland and the UK.



The PEGI system classifies video games in one of the age categories 3+, 7+, 12+, 16+ and 18+.

To date this has been a successful and welcome initiative as it provides a significant aid to parents in relation to the content suitability for young persons of various ages.

Although, as stated above, video games are exempt from classification under Section 1 of the Video Recordings Act, 1989, they may, in fact, be prohibited on grounds specified in Section 3 of that Act.

Consequently, games rated 18+ are now examined by IFCO to ensure compliance.

## ■ European and International Classification Developments

IFCO is a member of the Association of European Classifiers. The Irish Film Censor, John Kelleher, is a member of the Association's Steering Group.

At the European Conference in Paris in December 2004, members agreed to establish WMReF (World Media Regulators' e-Forum), an international electronic forum to facilitate communication within a secure environment between media regulatory bodies across the globe.

Jointly owned by its member organisations, membership of WMReF is restricted to media regulators working in the area of film, video and digital media throughout the world.

The main services the WMReF site provides are a confidential forum, a news desk, a research archive and links to media regulators' official websites and other sites of interest.


IFCO was among the first regulators to join the WMReF. Its membership now includes regulators in Australia, Austria, Belgium, Cyprus, Finland, France, Germany, Hungary, Iceland, Liechtenstein, Lithuania, Netherlands, New Zealand, Norway, Poland, Portugal, Singapore, Slovenia, South Africa, Sweden, the UK and the USA.

In December, the Film Censor's decision to give an Over 18 certificate to the feature film '*Closer*' was appealed by the distributor, on the grounds that the '16' certificate, scheduled to come into effect from 1st January 2005, would be more appropriate. The Censorship of Films Appeal Board upheld the Film Censor's decision.

Six cinema feature films were released on condition that a caution referring to violence was carried on all posters, print advertising and cinema listings. The films were:

## CERTIFICATION OF VIDEOS/DVDS

A new video fees structure was implemented by Ministerial Order on 1st June 2004 (S.I. 113 of 2004) that provides for video classification fees to be based on the duration of the video work submitted, rather than, as previously, where different rates applied for rental and sell-through. A flat fee of €50 per DVD extra/trailer/advert was also introduced. Accordingly, the 2004 certification figures are split between the period prior to 31st May and subsequent to 1st June.





A Prohibition Order was made in respect of one Video Work, '*Anabolic Initiations #5*' in 2004, details of which were published in Iris Oifigiúil. The distributor appealed the Prohibition Order to the Censorship of Films Appeal Board. The Appeals Board upheld the Film Censor's decision.

During 2004, at the request of both the Customs and Excise Branch of the Revenue Commissioners and the Garda Siochána, IFCO examined 195 video/DVD works, which were a sample of works seized by those authorities. Certificates were issued by IFCO stating that they would be prohibitable under section 7 of the Video Recordings Act 1989. These certificates can be used as evidence in cases brought by the above authorities.

Section 7 (3) of the Video Recordings Act, 1989, provides for the revocation of a prohibition order and the issue of a supply certificate. In 2004, Revocation Orders were issued in relation to two Video Works: '*From Dusk Till Dawn*' and '*From Dusk Till Dawn 2: Texas Blood Money*'.

## CERTIFICATION FOR COURT PROCEEDINGS

Complaints regarding breaches of the provisions of the Censorship of Films Act, 1923, and the Video Recordings Act, 1989, are referred by the Office to the Garda Síochána for investigation.

Under Section 23 of the Video Recordings Act, 1989, the Office of the Film Censor may issue certificates to provide certain information which is admissible as evidence in court proceedings.

## FINANCE

The fees charged by the Office for the certification of cinema films and videos/DVDs and for the issuing of licences in 2004 were as follows:

Fees charged for Film Certification	€246,801

A new film fees structure was implemented by Ministerial Order on 1st April 2004 (S.I. 114 of 2004). This provides for a reduced rate of €3 per minute in the case of films to be released on six prints or less. (See 'Revised Cinema Fees', page 4). The previous fee of €8 per minute was increased to €12 per minute for all other films with the exception of films of an educational nature, for which no charge is made. A flat fee of €100 for trailers was also introduced.

A new video fees structure was implemented by Ministerial Order on 1st June 2004 (S.I. 113 of 2004). This provides for video classification fees to be based on the duration of the video work submitted, rather than, as previously, where different rates applied for rental and sell-through. **John Kelleher**

John Kelleher was appointed Official Film Censor on 7th April 2003, following on a publicly advertised competition process. He succeeded Sheamus Smith, who had been Film Censor since 1986.



Born in Dublin, he graduated with a BCL degree from UCD and a Masters Degree in Drama from the University of Kentucky. He was called to the Bar in 1971. As a producer/director in RTE, he produced many award winning programmes, including 'Strumpet City' and 'Even the Olives Were Bleeding'.

He was appointed Controller of Television Programmes in 1980 and established the 'Today Tonight' programme in the same year. He left RTE in 1983 to become Managing Director of The Sunday Tribune.

For over twenty years, he was one of Ireland's leading independent film and television producers. He has produced six cinema films, including 'Eat the Peach', which he co-wrote, as well as six television drama series, numerous documentaries and four series of TV3's current affairs flagship, 'Agenda'. He is married with a son and a daughter.

**Ger Connolly**

Ger Connolly was appointed Deputy Censor in August 2003.

He was born and lives in Kildare town. He graduated from UCD with a B. Comm. Degree. He studied accountancy with Deloitte, Haskins & Sells, and worked in that capacity in the advertising and manufacturing industries.

He was appointed a part-time assistant film censor in November 1993. He served as Deputy Film Censor and was one of three Irish delegates to the Conference of European Film Classifiers in Dublin in 2001. He represents Ireland on the board of PEGI, the Pan European Games classification system, and sits on both its Advisory Board and Complaints Board. He is married with two sons and a daughter.

Born in Cork, she has worked in a number of areas within the Department of Justice, Equality and Law Reform, including the Prisons, Probation and Welfare Policy Division, the Garda Complaints Board and the Finance Division.

## FUTURE DEVELOPMENTS

### ■ Adolescents Survey

In early 2005, IFCO will publish the findings of a major national research survey into adolescent attitudes to film classification. The fieldwork for the survey was carried out jointly by the School of Communications, Dublin City University and the School of Business and Humanities, Dun Laoghaire IADT, under the supervision of Dr. Carol MacKeogh. Over one thousand adolescents were surveyed at twelve randomly selected second level schools throughout the country.

### ■ Public Awareness Campaign

It is intended to implement a media campaign in the first half of 2005 to augment the impact of the recently launched IFCO website. The main aim of the campaign would be to promote the website as a means of empowering parents to make better informed choices about what their children are watching. The Lansdowne Market Research survey indicated clearly that parents would warmly welcome such an initiative.



### ■ Research/Focus Groups

Building on the valuable feedback generated by the two major surveys conducted during 2004, IFCO plans to further invest in consumer research and to continue facilitating focus group discussions and screenings with a wide variety of interest groups and experts (e.g. psychologists, educators, etc.).

### ■ Revised Video Fees

It is hoped that a revised scale of fees, similar to the limited release scheme for cinema films, which favour limited release video/DVDs, will be implemented by way of Ministerial Order in early 2005. (see page 5)

### ■ IT Development Phase 2

Following on the successful completion of Phase 1, the IT Division of the Department of Justice, Equality and Law Reform plans to complete Phase 2 of its comprehensive development of the IFCO IT resource.

### ■ Legislative Reform

As referred to earlier (see page 8) IFCO hopes to contribute to the imminent review of censorship/classification legislation announced by the Minister for Justice, Equality and Law Reform.

### ■ International Cooperation

IFCO will continue to participate fully in discussion and debate with our European and international classification colleagues, principally through ongoing involvement in the Association of European Classifiers, the World Media Regulators' e-Forum and PEGI (Pan European Games Information System).

## ■ Gníomhaíocht Mhéadaithe/Láimhdeachas Méadaithe

I gcomparáid le 2003, mhéadaigh an lion priomhscannán pictiúrlainne 17% agus mhéadaigh an lion fiseán/DVDanna deimhnithe 16%. I gcás na scannán pictiúrlainne, is féidir an méadú sa lion deimnithe a lua cuij mhór leis an laghdú ar na tällí a gearradh, a tugadh isteach in Aibreán agus a raibh failte mhór roimhe, do scannán ar eisíunt theoranta (buiséad íseal, teanga íasachta, áras ealaíne, etc.) I gcás na bhfiseán/DVDanna, is féidir an méadú a lua le fás mór breise sa mhargadh DVD, cé go bhfuil tionchar an-mhór ag pioráideacht agus allmhairthe midhleathacha ar an margadh sin.

## ■ Réitigh TF agus Teicneolaiochta

I ndeireadh 2003, rinne Rannán TF na Roinne Dlí agus Cirt, Comhionannais agus Athchóiriúthe Dlí athbhreithniúr acmhainní TF an IFCO. Léirigh sé sin nár sholáthair na cártaí chuntaisaochta bunaithe ar Progress agus DataEase a bhí in úsáid ag IFCO chun idirbheartaiochtaí le daileoirí scannán agus fiseán a bhainistí, a bhí os ciorn deich mbláin d'aois, dóthain feidhmíulachta chun tacú le riachtanas gnó a bhí ag leathnú.

Chomh maith leis sin, comhaontáodh go mbeadh gá le bonneagar líonra uasghrádaithe chun tacú le hoibriú leanúnach feidhmchláir ghnó reatha agus amach anseo.

I rith 2004, d'fheidhmigh agus thástáil Rannán TF na Roinne Dlí agus Cirt, Comhionannais agus Athchóiriúthe Dlí go Rathúil an chéad chéim de mhór-nuachóiriú ar bhonneagar; ar chórais agus ar feidhmchláir an IFCO.

Forbróidh Céim 2, a thabharfar chun críche i rith 2005, ar na céimeanna eatramhacha a bhaineadh amach i gCéim 1 agus is é an toradh a bheidh air go ndeanfar seachadach níos iomláine ar réitigh teicneolaiochta lena mbaineann bonneagar; feidhmchláir agus seirbhísí gréasáin dhinimiciúla.

## ■ Láithreán Gréasáin

Tar éis tréimhse tástála, lenar áriodh comhchomhairle le tuismitheoiri, leis an bpobal agus leis an tionscal, seoladh láithreán gréasáin an IFCO an 3 Meán Fómhair 2004.

Ba é an aidhm ná timpeallacht dhinimiciúil, chuiditheach don úsaideoir agus fis-spreagúil a chruthú ina bhféadfadh an IFCO a réimse freagrachta reachtúil a chomhlionadh. Ag an am céanna, bhí sé i gceist teachtaireacht shoiléir a thabhairt go raibh Oifig Scrúdóir na Scannán nua-chóiriúthe go mór.

*Ba iad priomhspriocanna an láithreáin:*

- An pobal a chur ar an eolas ar shli shoiléir agus achomair faoina ndéanaimid ag IFCO.
- Treoirlinte ginearálta a fhoilsíú ag míniú ár gcur chuige i leith scannán agus fiseán/DVDanna a aicmiú

- Faisnéis tomholtóra a chur ar fáil do thuismitheoirí faoi scannán ar leithigh ionas go bhféadfadh siad a mbionn a leaná ag breathnú air a fhaire agus a cheadú.
- Ceanglaíse réimse freagrachta seirbhise poiblí an IFCO ó lá go lá a nascadh le tarraingt siamsaiochta thionscal na scannán.

Mar atá le feiceáil, tá ábhar an láithreáin dirithe go mór ar dhátaí eisiúnta scannán. Tugtar cothrom le data é go laethúil agus foilsitear eisiúnti nua pictiúrlainne gach Aoine. Tá innéacs inchuardaithe ann de na scannán ar fad atá ar eisiúint in Éirinn chomh maith leis na scannán atá aicmithe ó seoladh ar láithreáin. Tá sé beartaithé an bunachar sonraithe seo a leathnú chun scannán a címkiodh i mblianta roimhe sin a chur san áireamh, chomh maith le heisúint fiseán/DVDanna, in am tráthá. Maidir le struchtúr agus nascleanúint an láithreáin, is é an aidhm a bheith comhsheasmhach, imfhiosach agus tréadearcach, ag tabhairt rochtana éasca ar leithead agus ar dhoimhneas ábhar an láithreáin.

Maidir leis an dearadh fise, ba é an aidhm a bheith sonrach, spreagúil agus galánta, agus a bheith ábhartha don lucht féachana agus teachtaireacht a thabhairt faoi na tacáochtaí láithreáin – i.e. ba chóir go mbeadh sé tarraingteach ó thaobh grafaici de agus go mbeadh iomhánná scannán ann chomh maith le naisc chuguit léirmheasanna agus láithreáin gréasáin scannán.

D'fháiltigh an pobal, tuismitheoirí agus tionscal na siamsaiochta roimh an láithreáin. Bhí an t-aiseolas ó roinnt dár macasamhla idirnáisiúnta, m.sh. an Ríocht Aontaithe, an Astráil, an Fhrainc, dearfach.

## ■ Táillí Pictiúrlainne Athbhreithnithe

Cuireadh scála athbhreithnithe táillí chun scannán phictiúrlainne a dheimhníú i bhfeidhm le hOrdú Aireachta (Ionstraim Reachtúil Uimh. 114 de 2004), a raibh eifeachta leis ón 1 Aibreán 2004.

Mar a luadh i d'Tuarascáil Bhliantúil 2003 an IFCO, ni raibh aon mhéadú ar scála na dtáillí a gearradh chun scannán phictiúrlainne a dheimhníú ó 1987.

Cé gur méadaidh an táille a gearradh chun scannán phictiúrlainne priomhshleára a dheimhníu, laghdaiodh go suntasach na táilli a gearradh ar scannán 'áras Elaine' nó ar eisiúint theoranta – m.sh. le fotheidil, buiséad iseal, scannán dhúchasacha, leas mionlaigh, etc.

San am a caitheadh, chosnaiodh sé an méid céanna deimniú a dhéanamh ar scannán áras Elaine agus a chosnaiodh ar scannán priomhshleára. Anois, mar thoradh ar scála nua, tá an costas ar scannán áras Elaine an ceathair cuid de chostas scannán priomhshleára, agus dá bhri sin is inéanta do dháileoirí scannán den sórt sin a eisiúntanois.

De bhri gur iarr mé i mo Thuarsáil Bhliantúil do 2003 go dtabharfaí an tionscnamh seo isteach, tá áthas ar leith orm fáilte a chur roimhe anois. Tá fáilte fhial curtha ag an bpobal a bhíonn ag dul chuig scannán agus ag tionscal scannán na hÉireann roimhe freisin.

## ■ Táillí Físeán Athbhreithnithe

Cuireadh scála athbhreithnithe táillí chun fis-saothair a dheimhniú agus chun ceadúnais a eisiúint i bhfeidhm le hOrdú Aireachta (Ionstraim Reachtuit Uimh. 113 de 2004), a raibh éifeacht leis ón 1 Meitheamh 2004.

Mar a luadh i dTuascáil Bhliantúil 2003 an IFCO, ní raibh aon mhéadú ar scála na dtáillí a gearradh ina leith sin ó tugadh isteach den chéad uair iad i 1994.

Bheadh scála táillí dá shraith chun fis-saothair a dheimhniú, cosúil i gcoincheap leis an scála a bhfull imlín thusa air chun scannán phictiúrlainne a dheimhniú, ina fhobair dhearbach breise. ## ■ Athruithe ar Dheimhnithe Scannán Pictiúrlainne

Fógraíodh dhá athrú ar na haicmi dheimhniú scannán a bhí cheana ann an 9ú Nollaig, agus bhí éifeacht le bheith leo ón 1 Eanáir 2005.

- I. Athainmniodh na deimhnithe '12PG' agus '15PG' go dtí '12A' agus '15A', leis an 'A' ag seasamh do dhuine fásta [Adult].
2. Tugadh deimhniú nua '16' isteach, ag srianadh cead isteach chug pictiúrlann go dtí daoin sé bliana déag agus os a chionn.

I measc na chéad scannán a deimhniodh mar '16' bhí 'Kinsey', 'Team America: World Police' agus 'Million Dollar Baby'.

Rinneadh na hathruithe sin tar éis comhchomhairle le tuismitheoirí, oiliúinóiri, an pobal, dáileoirí scannán agus bainisteoirí pictiúrlainne. Chuir siad san áireamh freisin torthai shuirbhé náisiúnta ar thuismitheoirí a rinne Lansdowne Market Research don IFCO níos túisce sa bláthain.

## ■ Suirbhé ar Thuismitheoirí

D'fhoilsigh an IFCO an 3 Meán Fómhair torthai an chéad shuirbhé náisiúnta riagharsc iarrthóir thuismitheoirí maidir le ceistéanna a bhaineann le leanai a bheith ag breathnú ar scannán agus ar fhiseáin/DVDanna.

Ba é priomhaidhm an tsuirbhé, a rinne Lansdowne Market Research don IFCO, na priomhábhair spéise do thuismitheoirí i ndáil le hábhar agus aicmiú scannán agus físeán a shainainiú.

Rinne Lansdowne suirbhé ar 250 tuismitheoir leanai a bhí ag freastal ar 12 scoil iar-bhunoideachais, a roghnaiodh go randamach chun sampla ionadaioch a thabhairt chomh fada agus a bhain le comhdhéanamh ceantair, soch-eacnamaioch, inscne agus creidimh.

I measc priomhfhionnachtana shuirbhé Lansdowne bhí:



- Creideann 86% de na tuismitheoirí gur cheart go mbeadh an focal deiridh acusan faoinaí feidir lena leanai a bheith ag breathnú air nó gan a bheith ag breathnú air.
- Tá a fhios ag tromlach na dtuismitheoirí gur ann don IFCO agus tá a fhios acu cad a dhéanann sé.
- Deir 93% de na tuismitheoirí go léir go seiceálann siad an ráta aicmithe go rialta.
- Ar an iomlán, tá tuismitheoirí sásta leis na haicmí reatha (G, PG, 12PG, 15PG agus 18). Féachann siad orthu mar cheann de na priomhfhionnsi d'eoilas úsáideach faoi ábhar scannán agus mar thagairt thábhachtach nuair a bhíonn siad ag cinneadh cad ar chóir dá leanai a bheith ag breathnú air nó cad nár chóir dóibh a bheith ag breathnú air.
- Mar sin fein, tá mearbhalla ann mar, ann fein, seasann PG do 'threeiro tuismitheora' [parental guidance], ach nuair is 12PG nó 15PG é ciallaionn sé 'tionlacan tuismitheora nó caomhnóra' [parent or guardian accompanied].
- Deir beirt as gach triúr tuismitheoirí go gcomhaontaíonn siad go rialta le cinní aicmithe an IFCO.
- Deir duine as gach triúr go n-easaontaíonn siad amanna – agus deir an tromlach diobh sin go bhfuil an IFCO ródhian.
- Creideann direach os cionn 40% de na tuismitheoirí go raibh roinnt scannán atá rangaithe mar 12PG aicmithe 'ródhian', ach motháinn 25% nach raibh siad rangaithe 'dian a dhóthain'.
- Mothaíonn 45% de na tuismitheoirí go mbíonn scannán 15PG rangaite amanna, cé go motháíonn 38% go mbíonn an IFCO, ar uairibh, róbhog.
- Is é an imní is mó faoi ábhar i measc fhormhór na dtuismitheoirí ná druga/tóigáil drugaí agus foréigeann, agus ina dhiaidh sin tagairtí ciniocha agus ól meisciúil faoi aois. Is lú d'ábhar imní gníomhaiocht ghnéis/caint fao ghnéas, agus déanann formhór na dtuismitheoirí idirthealú go compordach idir ábhar gnéis agus noichte. Tá eascain agus caint láidir an-iseal i measc na dtsaoíochtaí imní.
- Suimiúil go leor, creideann tromlach na dtuismitheoirí gur comhthéacs iomlán agus teachtaireachtaí bunúsacha scannán ba chóir a bheith mar bhonn d'aicmiú – agus nach radharcanna aonair.
- Nuair is ógánaigh níos sine a bhí i gceist, mheas na tuismitheoirí gur mó de thionchar dochar a d'fhéadfadh a bheith ag an idirlion agus ag an teilifís ná ag scannán agus fiseáin/DVDanna.
- D'fháilteodh tuismitheoirí faoi thuileadh eolais faoina mbíonn i scannán. Dúirt beagnach a leath go dtabharfadh siad cuairt ar láithreán gréasáin an IFCO.




