From the LONDON GAZETTE.

Lepthorn, September 25.
On Saturday the 23d Instant, Rear Admiral Broderick arrived in this Port with his Britannick Majesty's Ships the Prince, Culloden, and Guernsey. As soon as these Ships have taken in their Water, and other Necessaries, they directly proceed to Sea again.

Bugor, Oct. 3. By Letters from Dresden, the King of Prussia has made a Motion towards Bautzen, with a View to engage Marshal Daun to a Battle, or to force him to retire into Bohemia. In the mean while, the Swedes have been working as several Encounters, and have retired towards Mecklenburg, owing to the Prince of Bevern's coming upon their flank, from Stettin, with a Corps of seven Battalions, 1200 Horses, and a Body of Light Troops, with which he leaves no Rest.

General Oberg was within a German Mile of Cassel, at the Village, on the 27th inst, after having been joined by the Prince of Yémbourg. The Prince of Soubise was engaged near the Town upon the Height of Kratzberg.

Blagay, Oct. 6. The Armies upon the Lippe are just what they were; and as General Oberg arrived a few Days too late, to cut the Prince of Soubise off from Cassel, he could only take an advantageous Position near him. It is very certain however, that the French are sending their Baggage and their Equipages towards Hanau; and it is generally believed, that they will endeavour soon to follow them, if they can do it without running too great a Risk.

GERMANY.

Dresden, Sept. 25. It is said this Electorale will be obliged to furnish the King of Prussia with eighteen thousand Men.

A Body of 6000 Men of Prince Henry's Army is marched towards the Chief of the Army of the King of Prussia, and cut off its Communication with Freyberg. Carriage of Provisions to the two Armies is attended with great Difficulties for want of Waggons. The Camp at present is in want of Well-water, the Prussians having destroyed all the Springs.

Sept. 27. This Morning the Enemy attack'd the Camp of the King of Prussia. The Action lasted till Ten o'Clock, when they were happily repulsed: However, to prevent any further Advances, Marshal Daun, who was Spectator of the Action, removed a great Corps of Troops from the Left to the Right of the Army.

FRANCE.

Paris, Oct. 2. The Scarcity of proper Timber having been the chief Cause of the little Progress in our Marine, the King's Order that Department has just agreed with a Company, to supply us with Wood from the Forests of Pyrenees. By this new Contract, a Mast that used to cost the sum of 1000 Pistoles, when brought from the North, will now be at the Rate of ten.

LOW-COUNTRIES.

Brussels, Oct. 2. On Wednesday fresh Complaints were made by Mr. York of the following Infault: Four English Ships, upon a Dutch Ship commanded by Captain Crittle, was bound to Algiers with the annual Presents of our King to the Dey, and had some Merchantmen under convoy, they attacked him, and by threatening to sink the Bottom, compelled him to bring to, and suffer a Search.

PLANTATION-NEWS.

St. Vincent, August 19. A Discovery was made of a Plot against the Government, by some of the Inhabitants of this Place and Neighbouring French and Indians, and was this Night to be executed. I shall write you just as it was: A Dutch waiting Man who frequented a House in Dutch-town, on Account of a certain young Woman who lived with her down the Cellar, and there discovered the Plot of a Parcel of Fire-arms loaded and primed, he made known to his Captain; thereupon Search was made, they were found and carried before the Governor, Enquiry being made, it appears there was a Plot against the Dutch, or some other dissatisfied Persons, the French and Indians, suddenly to fall in upon this Place, and destroy it with every Person who could not make his Escape. They took this Opportunity as our Men of War were all at Louisbourg. We are this Night to be all ready; tho' as their Designs are frustrated, we are in hopes they will return back to the Woods, and that we may be disturbed by them. We have now in Sight several Men of War from Louisbourg, so that we hope it will be in the Power of our Neighbours to disturb our Quietude. We have 14 Sail of the Line to winter here.

We received a Letter from Albany, August 20, 1758, that Monday Capt. Bradstreet, with 3339 Men, left the Carrying-place, and proceeded toward Lake Ontario, with a Train of Artillery, Mortars, Shells, &c. It is not certain whether they are designed against Ca-

terique, or Niagara; but generally thought the former, as I hear a Gentleman from the Great Carrying-place says, that two Defenders of Englishmen, from Cataracts, give an Account that there were but 40 Men in Fort Frontenac; and they were not in the least suspicious of any Army coming that Way this Year. That the Governor of Canada was expected in ten Days at Cataracts with large Presents for the Onandago Indians, who are to meet there on a Treaty. The remainder of the Troops at the Great Carrying-place are employed in building a Fort there.

Philadelphia, Aug. 31. Our last Advertis from the Westward are, that the Army was very healthy, and marching on towards Fort Duquesne, with all that Caution and Circumspection which the Danger and Difficulties attending such a March necessarily require, having met with no other Interruption than that of some straggling Parties of Indians: that on the 27th inst. some of our Waggons were attacked by a Party of the Enemy, between Fort Linton and Fort Juniata, when a Suter was made Prisoner, his Driver killed and scalped, and several of the Horses shot: that much about the same Time a Waggon was killed, and three others carried off, as they were going down Siding-hill: that a little Way from Colleton's Fort the Indians killed one Soldier, and carried off his Wife: and that near Shippenburgh six of our light Horse were fired at by them, when one Gullichart was killed, one is maimed and a Sergeant's Horse was shot under him, but he escaped.

Sept. 11. Thursday last arrived here Capt. Morton, and on Friday Capt. Ingraham, two Regiment from Louisbourg, having parted with the Convoy of about 40 Sail, in a Fog, two Days after they left that Place: the Remainder are hourly expected. By Capt. AWard of Consolation to General Fermor on his Defeat by the King of Prussia.

TIS said (and History reports it true)
From Fire that Stragges for ever flew;
Who then shall wonder, when the Tale he hears,
Why Fermor trembled, and why fled thy Bears,
Cornwall.

It is said that a separate Treaty is upon the Carpet between his Prussian Majesty and the Empress Queen of Hungary, upon the Solicitation of the latter, under the Mediation of the Kings of Spain and Sweden, and that Aix-la-Chapelle is the Place appointed for the Meeting of the different Ministers.

They write from Dresden, Sept. 29, That the Empress-Queen, who before the present War thought that (by her Alliance with France, Russia, Saxony, and Sweden) she should soon be enabled to destroy the King of Prussia, and divide his Country amongst herself and her Allies, was now so well convinced of her Mistake, that she had sent a Minister there, to inform himself upon what Conditions his Prussian Majesty was willing to come to an Accommodation; and that the said Gentleman was then actually in that City.

Commodore Keppel's Fleet is under Sailing Orders. An Express set out Yesterday, with some Dispatches for Admiral Boscawen at Plymouth.

Some private Letters from Madrid bring an Account, that the Queen Dowager of Spain was so ill of a Fever, that her Life seemed in great Danger.

Tuesday Night the Duke of Bedford arriv'd from Woodburn-Abbey, at his House in Bloomsbury-Square.

On Wednesday Night Duquesne, for falling dyed and adulterated Tea, was re-examin'd before a Magistrate in the Borough, and gave Information of the Persons of whom he bought it. He is kept in Custody till a Representation of the whole be laid before the Hon. the Commissioners of the Excise.

Advice is received from Copenhagen, that a Russian Man of War, of 64 Guns, is sail on the Dutch Coast, and that all the Crew perished.

Thursday Night and Yesterday Morning there was a smart Frost on the River below Bridge, and along both Shores, when a great many Steamers were impeded from the Homeward-bound Ships, &c. for His Majesty's Service.

TURKEY.

Constantinople, September 2.
The Plague continues to make great Harack at Pera and Galata: Whole Families have been cut off by it, which hath so frightened the rest, that they have fled to distant Places, leaving their Houses and their Trade.

RUSSIA.

Petersburgh, Sept. 15. The Turkish Envoy is at last set out on his return to Constantinople, highly disgusted at the little Respect paid him during his Residence here.

POLAND.

Warsaw, Sept. 24. We expect but little Good from the approaching General Dyet: Most of the Grandees of the Kingdom cannot bear the Thoughts of proceeding to the Election of a Successor to the Crown: They look upon such a Step as unreasonable, and wait for further Light into the Situation of Affairs.

Warsaw, Sept. 29. The King has received an Express with Advice that Prince Charles, his third Son, is elected Duke of Conland.

ITALY.

Rome, Sept. 24. The universal Jubilee began last Sunday by a solemn Procession from the Church of the Charities to the Basilique of St. Mary-Major, at which the Pope assisted on Foot, with 26 Cardinals, visiting the Limboes of all the Saints, &c.

His Holiness was taken very ill on Tuesday. On Thursday he was attacked with a Fever, which continues upon him; but we hope it will not be attended with any fatal Consequence.

GERMANY.

Vienna, Sept. 27. The King of Prussia having withdrawn almost all his Troops that were in Silesia, General Harisch has penetrated into that Province on the Side of the County of Glatz, with 20,000 Men, and General de Ville, who commands a Body of pretty near the same Force, was expected to join him the Day before Yesterday.

Prague, Sept. 27. We have just received Letters from Toplitz which assure us, that General Haddick has surpris'd, and taken in the Town of Freyberg, the Body of Prussian Volunteers, commanded by Col. Meyer, and that this Officer himself is taken Prisoner.

Dresden, Oct. 1. It is reported that the King of Prussia has cut off Marshal Daun's Communication with Bohemia. In this Case the Marshal must either evacuate Saxony or Fight.

Dresden, Oct. 1. The King of Prussia, who advanced with his Army the 28th of last Month from Pulstitz to Rammenau, and encamped the next Day on the Confines of the Upper-Lusatia, over-against Bischofswerda, and Yesterday his Van-guard took Post within a small Distance of Beyerow. Nothing important happened on Account of this March, except that the Prince of Baden-Doullach, who encamped in the Neighbourhood of Bautzen with a Body of 15,000 Men, decamped at the Approach of the King's Army, and took the Route of Zittau along with General Laudon, in order to cover the Austrian Magazines in that Place, and hinder the Prussians from penetrating into Bohemia.

For these several Days past nothing material has happened between the Troops under Prince Henry and the Army of the Empire, excepting that the Prussians have deprived the latter of all Communication with the Circle of the Mountains, and carried off several Magazines which they had formed in the Neighbourhood of Chemnitz.

Mr. Mitchell, the British Minister, is perfectly recovered from his Indisposition, and went two Days ago to Prince Henry's Camp, where he was received with Demonstrations of the highest Esteem and Regard.

Lipsiadt, Oct. 6. The French Troops are approaching this City: but, if they have any Design upon it, 'tis hoped we have a sufficient Garrison to defend us.

Cologne, Oct. 10. The Prince of Yémbourg and Gen. Oberg, after remaining six Days about half a League from Cassel, struck their Tents on the 3d, to remove back to an advantageous Position about a League distant.

FRANCE.

Paris, Oct. 6. A Pamphlet entitled *The Advantage of Marriage, and necessity for the Priests and Bishops of those Times to espouse Christian Maidens*, was burnt last Tuesday by the common Hangman, in pursuance of an Act of Parliament, which represents it as "containing erroneous Maxims, Explications of the sacred Writings contrary to the unanimous Interpretation of the Church, a Criticism and scandalous Distortion of the Doctrine of the Apostles; and an holy Fathers, and of the constant Discipline of the Catholic Church, &c." The Author, who is an Ecclesiastic, is committed to the Bastille.

Tho' our Generals may seem insipid in Germany, it is certain that our military Operations are exactly conformable to the Plan concerted with our Allies. If we employ the Allies of the King of Prussia, and prevent their going to his Assistance, or troubling Neutral States, we fulfill our Part and our Object. Indeed we expected to have seen Saxony delivered this Campaign; it should not be so, we shall next Year make great Efforts to accomplish that desirable Work.

A P R O C L A M A T I O N.

GEORGE ARMAGH. JOHN FORBESKY.
WHEREAS by Our Proclamation, bearing Date the Fifteenth Day of September last, an Embargo was laid upon all Ships and Vessels laden or to be laden with Provisions of any Kind, but only excepted, going from any Port in this Kingdom, to be continued for the Space of Six Weeks, from the Date of said Proclamation; but that the said Embargo should not extend to Ships and Vessels carrying Salted Beef, Pork and Butter, from this Kingdom to Great-Britain, pursuant to the Liberty granted for that Purpose, by an Act passed the last Session of Parliament in Great-Britain, nor to any Ships or Vessels that shall be Employed in carrying Provisions to His Majesty's Colonies, Islands and Plantations in America.

And whereas His Majesty hath signified His Royal Pleasure, that the said Embargo should be prolonged for the Space of Six Weeks, from the Twenty-seventh Day of this Instant October; on which Day the Time limited by Our said Proclamation will expire.

We therefore the Lords Justices and Council, do hereby Order and Direct, that the said Embargo be prolonged and do continue for the Space of Six Weeks, from the Twenty-seventh Day of October last.

And We do hereby signify Charge and Command all His Majesty's Collectors and Surveyors, and other Officers of the several Ports of this Kingdom, and all other Officers whom it may concern, that at their Peril they take Care to pay due Obedience thereto.

WHEREAS the Time limited by His Majesty's Order, in Council, of the 25th of July last, for paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able Landmen who shall voluntarily enter themselves in His Majesty's Royal Navy, and likewise for paying the Rewards to Persons discovering Seamen who shall conceal themselves, is near expiring; And whereas it is judged expedient for His Majesty's Service, that the Bounties and Rewards thereby given, should be continued to be paid for some Time longer; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to such Seamen and Landmen respectively, who shall, on or before the 15th Day of November next, enter themselves in the Royal Navy, in the Manner directed by His Majesty's Proclamation of the Fourth Day of January 1757; And likewise, That the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Person who shall, on or before the said 15th Day of November next, discover any Seaman or Seamen who shall conceal themselves, in as such Seaman or Seamen be taken for His Majesty's Service.—Whereof all Persons concerned are to take Notice, and govern themselves accordingly.
